#### EDWARD WATERS COLLEGE MAKES HISTORY FOR WOMEN'S HISTORY MONTH **SWEARING IN FIRST FEMALE PRESIDENT IN THE HISTORY OF THE COLLEGE**

#### CONGRESSWOMAN CORRINE BROWN, DR. JOHNNETTA COLE, DR. TRUDDIE TIBBE REED, AND OTHER COMMUNITY LEADERS GATHERED TO WELCOME THE 28TH PRESIDENT EDWARD WATERS COLLEGE: DR. CLAUDETTE WILLIAMS

Dr. Williams Became the First Female President of the 142-Year-Old Private African American College

Claudette Williams, Ed. D, was inaugurated as the 28th president of Edward Waters College (EWC) on Saturday, March 15 at 10 a.m. The Board of Trustees elected Dr. Williams President of EWC in June 2007. More than 700 people from the Jacksonville area, along with college and university president's from around the country and the state of Florida, participated in the event and celebrated a new beginning for the private African American College. Dr. Johnnetta Betsch Cole, Jacksonville native and President Emerita of Bennett College for Women and Spelman College, delivered keynote remarks, stated "having worked with Dr. Williams, she is a woman of great excellence, in my career I would rank her among the top TWO academicians that she has ever worked with."

"It was amazing to receive strong support from such a diverse audience during my inauguration ceremony – from students to faculty to our community church leaders to business people from around the city of Jacksonville." said Dr. Williams. "The strength of this community will be fundamental in our efforts to bring Edward Waters College into the 21st century."

Numerous business leaders, clergy, religious organizations, community groups and elected officials - including U.S. Congresswoman Corrine Brown, State Senator Anthony "Tony" Hill, State Representative Audrey Gibson, Jacksonville Mayor John Peyton, Jacksonville City Councilman Warren Jones, Jacksonville City Councilwoman Mia Jones, former Jacksonville Sheriff Nat Glover, and Dr. Johnnetta Betsch Cole, President Emerita of Bennett College for Women and Spelman College – took part in the event.

Inspired by Dr. William' vision, CSX Transportation's CEO Michael Ward donated \$1 million to EWC, which will be used to repair basic infrastructure such as elevators, roofing and plumbing, as well as improve campus security and support the EWC marching band with new uniforms, scholarships and repaired instruments.







## Diabetes..... The Deadly Epidemic among African Americans

Diabetes is a group of diseases marked by high blood sugar levels resulting in defects of insulin production, insulin action or both. Diabetes can lead to serious complications and premature death if steps to control diabetes are not implemented. Diabetes is the fifth leading cause of death in African Americans and their death rates are twenty seven percent higher than whites.

According to the "National Diabetes Education Program", 3.2 million African Americans age 20 and older have diabetes, 1/3rd of who are not diagnosed. African

Americans are 1.8 times more likely to have diabetes as non-Hispanic Whites of similar age. The cause of diabetes is a mystery, but researchers believe that both genetics and environmental factors determine who will develop the disease.

#### **Types of Diabetes:**

Pre-diabetes is when a person's blood sugar levels are higher than normal but not high enough for a diagnosis of type II. Pre-diabetes can often be controlled by monitoring blood sugar levels and change in lifestyle habits. This can often prevent or delay the onset of type II diabetes.

**Type I** diabetes is when the body's immune system attacks and destroys its own insulin -producing beta cells in the pancreas. People with Type I diabetes must take insulin.

**Type II** diabetes is when the body does not make enough insulin or cannot use the insulin it makes effectively. This particular diabetes occurs in adults over the age of 40 but is becoming prevalent in younger people including children and adolescents.

#### **Signs and Symptoms of Diabetes:**

Increased thirst and urination - Constant hunger Weight loss - Blurred vision Extreme fatigue - Slow healing wounds

#### The following factors increase a person's risk for diabetes:

Family history of diabetes

African American

Obesity (overweight)

High Blood Pressure

Abnormal cholesterol and or triglyceride levels

Lack of exercise (activity)

Metabolic Syndrome (abdominal obesity, elevated triglycerides, low HDL, high blood pressure, fasting blood glucose of greater than 120)

#### **Complications of Diabetes:**

Diabetes can lead to many disabling and life threatening complications. Strokes, blindness, kidney failure, heart disease, and amputations are common among African Americans who have diabetes

What can you do to prevent Diabetes Complications?

Because diabetes is a self managed disease, diabetics must take responsibility in their care. Blood sugar levels, blood pressure, and cholesterol levels must be in target range.

Blood sugar levels 70-110 (pre-meal) Cholesterol levels HDL (good cholesterol) greater than 50 LDL (bad cholesterol) less than 100 Blood Pressure Less than 130/80




## 4 Top Reasons for Knowing When It's Right To File For Bankruptcy.

In my first article, *How Bankruptcy Can Work For You*, I discussed the credit/debt crisis spreading across the country and how the filing of bankruptcy is a feasible option for individuals seeking debt relief under the new bankruptcy laws. In this article, I will explain my top 4 reasons for knowing when it's right to file for bankruptcy protection.

First, you make acquiring a fresh new start for you and your family a primary goal for your life. If one cannot realistically satisfy his or her basic living expenses, then the same rationale applies to your creditors. Therefore, as time passes, you will not be able to care for your debtors, who undoubtedly shall seek judgments against you for the debts that remain unpaid. Moreover, judgments rarely go away, given Florida's 20 year statute of limitations for enforcement of judgments. Subsequently, garnishments, liens and bank levies cannot be avoided and bankruptcy becomes the only feasible means for retaining secured assets (i.e. homestead and/or financed automobile) while seeking debt relief for all unsecured debt (credit cards, medical expenses and other unpaid bills).

Secondly, you save your house from foreclosure when the mortgage company refuses to negotiate a settlement. Perspective clients often





complain that their mortgage companies refuse to negotiate a work out agreement which they believe is in the best interest of all parties involved. However, they assume their lenders will realize that it is better for the lender to adjust their mortgage payment schedule than to force the borrower into foreclosure. Although some lenders will work out customized deals with mortgage borrowers, most lenders will not deal with borrowers individual financial situations and modification requests because most mortgages are no longer held by originating lenders. According to a *Wall Street Journal* article written by economist Martin Feldstein, most mortgages are "securitized and sold to investors worldwide. More significant, mortgages are used to create complex, asset-backed securities that are central to current credit-market problems. Investors no longer owns specific mortgages but only have rights to certain conditional payment streams. So generally, it is no longer possible to prevent foreclosure by negotiations between borrowers and lenders." In brief, filing for bankruptcy protection is the better alternative to losing your home when there is no one available to negotiate with.

Third, your credit can be improved over time by filing for bankruptcy protection. A frequently quoted myth of bankruptcy centers upon its negative impact of credit scores of individuals. A bankruptcy stays on one's credit for a period of 7 years for a Chapter 13 personal reorganization bankruptcy from the date of filing, which typically takes 3 to 5 years to complete, therefore it would completely disappear 2 to 4 years thereafter. However, if a Chapter 13 bankruptcy is dismissed, it will still remain on a credit report for 7 years from the date of filing. As for a Chapter 7 liquidation bankruptcy, the bankruptcy stays on one's credit for a period of 10 years. It is common knowledge that the filing of bankruptcy negatively impacts one's credit score but this negative effect weakens over time. For example, a two year old bankruptcy means more to creditors than a six year old bankruptcy because creditors are primarily interested in present financial circumstances. Consequently, if one's debt-to-income ratio is much improved from years earlier, the negative effect of a prior bankruptcy is minimized. Furthermore,

Fourth, bankruptcy affords consumers job security. People frequently ask, "can I lose my job if I file for bankruptcy and my employer finds out?" Therefore, it is important that individuals understand that bankruptcy is a matter of public record, which means that there is very little that one can do to maintain the privacy of his or her filing for bankruptcy protection. As for employment, the Bankruptcy Code addresses employment security as Section 525 of the Bankruptcy Code which provides that "no private employer may terminate the employment of, or discriminate with respect to employment' against a debtor. The issue is that most employers are not going to say that bankruptcy is the reason why an employee was terminated or not given a promotion, which requires the exercise of reasonable discretion when seeking bankruptcy protection while employed by financial institutions or other employers who express a strong interest in the financial affairs of its employees for the sake of its business relationship with the general public.

While there are many other reasons to file bankruptcy, the fact of the matter is that there is always more good that arises from any bankruptcy than the short-term negatives. The advisability of bankruptcy filing, and the best time to file, are contingent on the amount and type of debt burdening an individual debtor. Debtors who select a particular Chapter of the Bankruptcy Code must be sure that they can satisfy its requirements for filing under that particular Chapter. If you are considering filing of bankruptcy and are in substantial debt, take your most recent paystub and list of creditors to an experienced bankruptcy attorney and be open minded. In short, it is important that we change our way of thinking about solving any debt or credit crisis by exploring all options, including but not limited to the filing of bankruptcy when seeking relief from debt to acquire a fresh new start.



Ag-Discovery Summer Program at FAMU

TALLAHASSEE, Fla. – High school students seeking adventure, excitement and new knowledge are invited to apply for the Ag-Discovery Summer Program at Florida A&M University (FAMU). Online applications are now being accepted from high school students, ages 14-17, who are interested in participating in the program. Sponsored through the FAMU Cooperative Extension Program, the program is scheduled for June 8–27, 2008, in Tallahassee, Florida.

Now in its fourth year of implementation, the Ag-Discovery program is a three-week summer outreach camp sponsored jointly by the FAMU College of Engineering Sciences, Technology and Agriculture (CESTA) and the Animal and Plant Health Inspection Service (APHIS) of the United States Department of Agriculture. The unique program is designed to expose teenagers to careers in the animal science and veterinary medicine fields. Students live on campus and learn about science from university professors, practicing veterinarians, entomologists and botanists employed by the United States government.

"Students can expect to gain valuable experience from the program through the many diverse hands-on activities, workshops and field trips that are scheduled," said Ray Mobley, interim director of the FAMU Cooperative Extension Program. "They also are able to develop skills in teamwork and leadership. Each summer students

experience a first-hand look at the agricultural and scientific fields of study at Florida A&M

University and in CESTA. We welcome the opportunity to work with outstanding students who are prospective college scholars and future professionals."

The program is designed for a limited number of students to participate each year. Persons selected to participate in the Ag-Discovery program will only be required to pay the cost of transportation to and from FAMU.

The cost of tuition, room and board, and lab supplies for the entire program is funded by the United States Department of Agriculture, APHIS Animal Care program.

To be accepted in the program, students between ages 14-17 must complete and submit applications for the program by April 27, 2008. The application package is available online at www.aphis.usda.gov, www.famu.edu/herds and www.famu.edu/index.cfm?a=cesta.



I am reminded of the story of a thousand people in a dark cave, each with a flashlight, all pointed in the same direction. The scene is one of





## BREAST IS BEST

Although there are many hesitations and reservations from mothers, there are many benefits of breastfeeding. Even if a mother only breastfeeds for a short period of time, the baby's immune system can benefit from the breast milk.

There are many benefits of breastfeeding for a baby. Breast milk is the most complete form of nutrition for infants. A mother's milk has the perfect combination of fat, sugar, water, and protein. With this right amount, babies find it easier to digest breast milk rather than formula. As a result of having this amount of breast milk, infants grow as they should. Premature babies who were breastfed are healthier than premature babies who were fed formula. Also there is a greater protection against ear infections, colds, and viruses. If a child does have any of these illnesses, the severity will definitely be lessened. Breast milk also helps with brain development, and may help with learning and behavioral difficulties.

There are also benefits for a mother who decides to breastfeed. Nursing a child uses up extra calories, making it easier to lose the pounds of post-pregnancy. It also helps the uterus to return back to its normal size and relieves any bleeding a woman may have after giving birth. Breastfeeding also delays the return of normal ovulation and menstrual cycles for the mother who only breastfeeds, and/or alternates with the use of formula. Breastfeeding lowers the risk of breast and ovarian cancers.

If you plan on nursing your child, you should begin nursing as soon as possible. You want to introduce your child to the breast. Sucking in frequent bursts and pauses is the typical pattern for the first few hours and often the first few days.

The key to breastfeeding is getting the child to latch on properly and well. When a baby latches on poorly, milk does not reach the baby and may cause pain to the mother, which also results in staying at the breast for a longer period of time.



By nursing frequently, your body stimulates your milk supply, and may alleviate engorgement. Pain is not a normal indicator of breastfeeding. Usually it is a sign that something indeed is wrong, and you should try to fix the problem immediately by consulting your doctor.

Breastfeeding should become a routine and be done at regular intervals. Around every three hours, a feeding should occur. The normal length of breastfeeding is shorter during the beginning stages because the baby tends to tire out. However, 15-20 minutes is a good amount of time for a proper feeding. Breast feeding for more than 25-30 minutes can lead to the baby gaining excess weight.


## THE YOUNG MAN'S GUIDE TO RESOLVING CONFLICT

## Dealing with Grief!

I recently spoke with a person about a tragic moment in their life after church one Sunday. And I was hurt by the fact that no one at their home church had taken the time to do Grief Counseling with them. This is a dangerous situation especially here in the Jacksonville area where so many tragic events are taking place daily. Grief Counseling is an extremely important part of ministry! There are many who have to deal with tragic events by themselves, and they don't deal with grief well at all.

Many churches don't offer Grief Counseling and don't have anyone who is trained to deal with grief. What this does is force the grieving person to deal with grief in the manner that Christ did, all on their own! The problem is that they are not nearly as strong and able to do so as Christ was. Christ was able to go up into the mountains where he was ministered to by angels. Most people today are not that strong, that's why the church is to be that support for those who are dealing with grief.

There is an important fact that we must realize as it pertains to both Grief and Loss. Grief and loss are an ever present and universal reality. Since this is true, it isn't a matter of how to avoid grief and loss but how to cope with it. Careless and unwise advice and direction can complicate a person's grief.

Many people try and give comforting words to those dealing with grief and loss, and will sorrowfully say things like "Don't worry, it will be over soon." Well, I'm sorry, but it won't be over as soon as most people think. On the average the grieving process takes from 12 to 18 months. Some licensed counselors will go up to 24 months. Why? The grieving person must face the anniversary of the event or



loss, than birthdays and holidays without their love one. To

them the pain starts all over and over again, especially when there was no one to give them Godly counsel. For those who have gone past the 24 month period, this process has become abnormal and they need to seek a professional counselor.

Grief is inescapable and universal, we will all in some way experience grief. The Book of Job tells us two points about grief, which is referred to as trouble in this book:

Yet man is born unto trouble, as the sparks fly upward. KJV

Job 14:1

Man that is born of a woman is of few days, and full of trouble. KJV

So then what is "Grief"? Grief is the cognitive and emotional response to a significant loss; it includes the loss of anyone or anything (person, position, or place) that has emotional value. – Loss by death is the most significant permanent loss. – Some refer to grief as the price we pay for caring for one another. – Grief is a universal process of attempting to cope with any personal loss.

As a Shepherd appointed by Christ, to lead those he sends to me, I take the responsibility to guard the total man, just as all of those called to the Gospel Ministry of Christ, we must give the flock of God comfort to their souls! 

or challenges arise. As, I reflect I he speaks, I hear him and I see him. He was changing the way I think and teaching me about life. Changing the way you think about conflict or anything will give you the results you need to be successful in today's society. Before you can impact anyone to change the way they think we must first know thy self. Meaning, we must get a better understanding about ourselves and about our knowledge on the subject. Teachers and professors call this a pretest to assess how much you know or don't know about the subject. Psychologist and Counselors call the process an assessment tool. Regardless, of what it is called the purpose is to get a better understanding about yourself through fact-finding and soul searching.

I would like you to complete the following three Self-Assessment Empowerment exercises, which will assist you in finding the "root-causes" of conflict in your life. Be honest with yourself and don't be afraid of the results, because you will have some strategies to assist you in resolving conflict in the early stages.

It is important in resolving conflict that you identify the "root cause" to be able to resolve the real indicator(s) of the conflict. Attempting successful conflict resolution requires actively "listening to" all parties involved and providing an opportunity for all parties to participate. As a Mediator, I have resolved and settled many disputes and employment complaint cases. It required me to listen for several hours to all parties.

Mediation involves having a neutral third party resolve or settles your dispute. Some instances it could be a teacher, parent, clergy member or another neutral party. Professionals in Conflict Resolution seek to get win-win results for parties involve in the dispute, versus obtaining a win-lose situation. Years, ago I enjoyed watching the Andy Griffin Show. Whenever conflict arose, in town of Mayberry, the deputy sheriff, Barney Fife famous quote was, "Andy we've got to nip it".

That is the goal in resolving conflict to process the resolution in the early stage, "nip it". On your journey to success you want to resolve the conflict and not dissolve the relationships. 

Sylvester King fought to end segregated cab service in Orlando during the 1970s. As a driver for the Dixie Cab Co., King saw how the company's black drivers received unequal treatment in comparison with white drivers who worked for the City Cab and Yellow Cab companies. King

protested the unfair system of paying black drivers less than white drivers.



"I'm honored that they see me as worthy," said Lynum, whose accomplishments include advocating for the opening of Florida A&M University's law school in the Parramore neighborhood. Attorneys Wells and Wilson received awards for their work in Segregated Cab case for

King in 1975. "I look forward to the day when diversity and equality are universal," said Wilson, upon receiving his award. Demings was the city's first black chief of police and worked to eliminate racial bias on the force.

More than 250 people attended the luncheon at the Orlando Marriott Downtown. "The highlight was being able to hear from the trailblazers themselves," said state Rep. Geraldine Thompson, D-Orlando, who presided over the gathering. As the founder of PAST Inc., Thompson described a trailblazer as "one who has taken a path that others have not taken before, and they have left a trail that others can follow."

I enjoyed the lunch and especially the special friends that accompanied me at my table, State Senator Gary Siplin, State Representative Darren Soto, Orange County Democratic Chairman Bill Robinson, Orange County Democratic State Committeewoman Nancy Jacobson and her husband, Orange County Soil & Water Commissioner Susan Clary, and NAACP President Rev. Randolph Bracy (who actually ended up sitting on the dias) and his wife LaVon.

Together we watched a historical overview provided by PAST, which operates the Wells'Built Museum of African American History and Culture in Orlando, and a slides presentation showing newspaper articles about Civil-Rights issues as pictures of the trailblazers flashed across the screen with Sam Cook's "A Change Is Going to Come" playing in the background.



#### I AM JUST A NOBODY WHO WANTS TO TELL SOMEBODY ABOUT JESUS



## the PASTOR and the SENATOR

Arriving in Washington DC during the '80s, my most difficult challenge was finding a church home. Having grown up in the Pentecostal and Methodist faith, Sunday worship was a staple of my weekly routine. For almost 10 years I canvassed the nation's capital seeking a church that would take my fleshly failings and remind me of what our Creator expects of us as human beings.


What was consistent in going from pulpit to pulpit was that ministers were more interested in political rhetoric, the endorsement of political candidates and the denouncing of some government or community proposal, than the Gospel. It was disheartening for many years knowing that ministers were not teaching or preaching the word of God, that their sermons were becoming political rallies. I was stunned by the relentless blame cast upon the white man, by the rhetoric of racial divisiveness and the emphasis on things that seemed to separate us from our neighbors.

Then, in 1995, I attended First Baptist Church in DC, where the Rev. Frank Tucker presided, and my spirit finally found what it was seeking. I will never forget meeting with the pastor prior to joining and expressing my feelings about what I was looking for in a church. I made it clear that my interest was in the word of God and not in political rallies, condemnation of America, and various politicians occupying the pulpit on Sunday. He shared my concerns and promised that this wasn't the case at his church.

I've been a member of Pastor Tucker's church for about 13 years now, and he's never disappointed my spiritual yearning. Through the years I've taken whites, Muslims, Jews and people of all walks of life to worship with me, and they all have left feeling that they could join the pastor's congregation.

Only cynics close their eyes to reality Obama spurns Pastor's 'distorted' views but won't disown him, says Armstrong Williams,

former Bush spokesman slams Obama over pastor. THERE ARE still black churches and mosques today that identify with the Rev. Jeremiah Wright's anti-American, hypocritical sermons. During the '50s, '60s and '70s, the black church was a place where blacks could gather and unite away from the harshness and brutality of racism and vicious hatred. It was a place where ministers could help their congregations express their anger and frustration at white America's ungodliness toward

their black brethren. Many ministers during those tumultuous times were considered heroes and pillars of the community for they were preaching against an eye for an eye and a tooth for a tooth.

People like Jeremiah Wright are still preaching as though we're in the '50s or '60s, and are locked in this time warp. They refuse to elevate and celebrate the progress of America and acknowledge that presidential candidate Barack Obama's campaign is evidence of that amazing paradigm shift.

It strikes me as impossible for Senator Barack Obama and his wife to have patronized Rev. Wright's church for so many years and not embraced his teachings and vision of America. My minister has always had a profound impact on my outlook on life and has strengthened my spirit to forgive the transgressions of this world and not induce more hate and separation.

I find it difficult to believe Senator Obama when he tells us that he was unaware of his pastor's vicious message from the pulpit, and that had he known it, there would have been condemnation. Many black intellectuals are still angry over what they perceive as the continuous crippling effect of racism and slavery in America on their careers. The irony is that many of their children have embraced the United States, finding success and prosperity, while their parents continue to allow their wounds to be perpetuated in this hopeless mind-set preached from the pulpit.

## "GOD'S TIMETABLES"

I remember my early years of school in those math classes at John G. Riley Elementary

School. The first things that we learned were addition, subtraction, division and then we were taught our timetables. My mind ran back the other day to the Book of Ecclesiastes 3:1 which says, "To everything there is a season, and a time to every purpose under the heaven". This great passage was written by David's son, Solomon, who was considered the wisest man in the bible not because of the time in which he lived, but because he allowed God to become first priority in his life.

#### These are God's Timetables:

**0x= Revelation 7:9** tells us that "After this I beheld, and lo a great multitude, which no man could number, of all the nations, and kindred, and people and tongues, stood before the Lamb, clothed with white robes, and palms in their hands". We need to know that we have an inclusive God.

1x= Exodus 20: 2-3 says "I am the Lord thou God who brought you out of the land of Egypt out of the house of bondage. Thou shalt have no other God before me." This means One Lord, One Faith and One Baptism.

5x= David picked up five smooth stones to fight Goliath (Samuel 17:40). We need to eat the fruits of the spirit which are love, joy, peace, longsuffering and faith (Galatians 5:22).

**6x= In Exodus Chapter Twenty the Lord created heaven and the earth, and then he rested.** Revelation 14:13 says "Blessed are the dead who die in the Lord. From henceforth: Yea, says the spirit that they may rest from their labor and their work do follow them".

**7x= Seven represents spiritual completeness and perfection.** There are seven days in one week. No prayer makes a child of God weak. The seven churches in Asia Minor show us a specific message and present us with a yardstick in which to measure the church of Jesus Christ.

**8x= Represents the eight people left after the flood**, Noah, his wife, their three sons and their wives. The songwriter says "Like a ship that's tossed and driven, battered by the angry see, when the storm of life is raging and the billows fall on me. I wondered what have I done to make

this race so hard to run and then I say to my soul take courage, the Lord will make a way somehow".

9x= Represents the nine lepers who did not come back to tell Jesus thanks for healing them. The Word of God says "In everything give thanks".

**10x=** Represents the ten virgins who went to the wedding. Five were wise and five were foolish. As did Solomon, we sometimes make some wise decisions and some foolish decisions. However, the songwriter says "I've decided to make Jesus my choice".

11x= Represents the happy hour of the Christian faith on Sunday mornings at 11:00 AM. Many may consider from 5:00 – 8:00 PM their happy hour on Fridays but David said "I was glad when they said unto me; let us go into the House of the Lord".

12x= Represents the Disciples of Jesus. The Lord has a job for each of us to do; we have a charge to keep and a God to glorify.

school of thinking. Furthermore, he should state that no one should be a member of churches or mosques which preach such hatred and conspiratorial thinking, continuously emphasizing the worst in our country and not the phenomenal progress made.

This past week was not an exemplary moment for the man who has prided himself on integrity and honesty throughout this campaign. The fact is that the senator has no plausible excuse for why he remained a member of Rev. Wright's church. He and his family should have immediately left that congregation for the embrace of a church that teaches the Bible rather than the alienation, lunacy and outright mockery of Christian teachings.

It was impossible for my spirit to endure these churches, as can be evidenced by my negative descriptions of them. It makes no sense for someone in search of America's promise and potential to worship in a place where a doctrine of hatred is the central theme. I was taught that church was a place of escape and rest; I didn't want someone who is supposed to be a religious leader feeding me poisonous information.


